Health Information

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Some people may be more vulnerable to contaminants in drinking water than the general population. Educational information

The sources of drinking water, both tap water and bottled water, include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.

- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic

wastewater discharges, oil and gas production, mining or farming.

- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.

- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems.

- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which shall provide the same protection for public health.

Detected Contaminants

Your water was tested for many contaminants last year. We are allowed to monitor for some contaminants less frequently than once a year. The following tables list only those contaminants which were detected in your water. If a contaminant was detected, it will appear in the following tables without a sample date. If the contaminant was not monitored last year, but was detected within the last 5 year, it will appear in the tables below along with the sample date.

(AL) - Action Level: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

HA or HAL - HA: Health Advisory. An estimate of acceptable drinking water levels for a chemical substance based in health effects information.

HAL: Health Advisory Level: The concentration of a contaminant which, if exceeded, poses a health risk and may require a system to post a public notice. Health Advisories are determined by US EPA.

HI - Hazard Index: A Hazard Index is used to access the potential health impacts associated with mixtures of contaminants. Hazard Index guidance for a class of contaminants or mixture of contaminants may be determined by the US EPA or Wisconsin Department of Health Services. If a Health Index is exceeded a system may be required to post a public notice.

Level 1 Assessment: A Level 1 assessment is a study of the water system to identify potential problems and determine, if possible, why total coliform bacteria have been found in our water system.

Level 2 Assessment: A Level 2 assessment is a very detailed study of the water system to identify

potential problems and determine, if possible, why an E. coli MCL violation has occurred or why total coliform bacteria have been found in our water system, or both, on multiple occasions.

(MCL) - Maximum Contaminant Level: The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

(MCLG) - Maximum Contaminant Level Goal - The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

(MFL) - Million Fibers per Liter

(MRDL) - Maximum residual disinfectant level. The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

(MRDLG) - Maximum residual disinfectant level goal: The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

(mrem/year) Millirems per year - a measure of radiation absorbed by the body.

(NTU) - Nephelometric Turbidity Units

(pCi/l) - Picocuries per liter - a measure of the radioactivity.

(ppm) - Parts per million or Milligrams per liter (mg/l)

(ppb) - Parts per billion or Micrograms per liter (ug/l)

(ppt) - Parts per trillion or Nanograms per liter

(ppq) - Parts per quadrillion or Picograms per liter

PHGS - Public Health Groundwater Standards are found in NR 140 Groundwater Quality. The concentration of a contaminant which, if exceeded, poses a health risk and may require a system to post a public notice.

RPHGS - Recommended Public Health Groundwater Standards: Groundwater standards proposed by the Wisconsin Department of Health Services. The concentration of a contaminant which, if exceeded, poses a health risk and may require a system to post a public notice.

SMCL - secondary drinking water standards or Secondary Maximum Contaminant Levels for contaminants that affect taste, odor or appearance of the drinking water. The SMCLs do not represent health standards.

(TCR) - Total Coliform Rule

(TT) - Treatment Technique - A required process intended to reduce the level of a contaminant in drinking water.

Additional Health Information

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Darlington Waterworks is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. ARSENIC - Erosion of natural deposits; Runoff from orchards; Runoff from glass and electronics production wastes

BARIUM - Discharge of drilling wastes; Discharge from metal refineries; Erosion of natural deposits

FLUORIDE - Erosion of natural deposits; Water additive which promotes strong teeth; Discharge from fertilizer and aluminum factories

NICKEL - Nickel occurs naturally in soils; ground water and surface waters and is often used in electroplating, stainless steel and alloy products

NITRATE - Runoff from fertilizer use; Leaching from septic tanks, sewage; Erosion of natural deposits

SODIUM - n/a

COPPER - Corrosion of household plumbing systems; Erosion of natural deposits; Leaching from wood preservatives

LEAD - Corrosion of household plumbing systems; Erosion of natural deposits

RADIUM - Erosion of natural deposits

GROSS ALPHA EXCL. R&U - Erosion of natural deposits

GROSS ALPHA INCL. R&U - Erosion of natural deposits

COMBINED URANIUM - Erosion of natural deposits

HAA5 - By-product of drinking water chlorination
